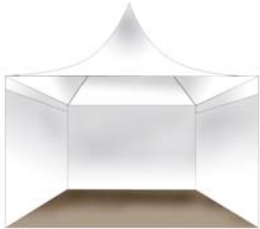

**TERMS & CONDITIONS FOR ADMITTANCE TO THE  
ANTIBES YACHT SHOW APRIL 12 – 15<sup>TH</sup> 2012  
SHORT VERSION**

**Article 1: DEFINITIONS -**

"Organizer" refers to the Antibes Yacht Show whose head offices are located at 9 Avenue St Roch 06600 Antibes, France, duly registered with the Antibes Business Registry under number 412.658.767.

"Exhibitor" refers to any company, organization having applied for and obtained a spot in the Show, or any agent, representative or employee of the Exhibitor.

"Show" refers to the Antibes Yacht Show to be held April 12 – 15, 2012 on the pier of the Vauban Port.

"Registration Contract": Set of documents comprised of the Terms & Conditions hereby, the Exhibitor's registration form and the Specific Conditions of the Yacht Show Registration validated by the Organizer.

**Article 2: RESERVING SPACE**

2.1/ Any party wishing to exhibit will forward the Organizer an application to participate which can be downloaded on the site: [www.antibesyachtshow.com](http://www.antibesyachtshow.com), or available upon request at the following address: [info@antibesyachtshow.com](mailto:info@antibesyachtshow.com) or the Antibes Yacht Show at 9 Avenue St Roch – 06600 Antibes.

Unless the Organizer rejects the application for participation, sending the said application constitutes the Registration Contract and will be a firm and irrevocable agreement to pay the total price of stand rental, berth for yacht in water or space for boat on land and related expenses.

All reservations become effective solely upon signature of the participation application, acceptance of the regulations hereby and upon payment of a minimum deposit of 30%. The balance must be paid on March 1<sup>st</sup>, 2012 by the latest under penalty of cancellation of said reservation.

2.2/ The application form must be submitted to the Organizer for approval, sole entity empowered

to pronounce Exhibitor admittance. **The Exhibitor does not have the right to choose the spot to occupy.**

2.3/ The Terms & Conditions hereby apply to all Exhibitors, their principals and service providers. When signing the registration form, Exhibitors accept all the regulations thereof. Exhibitors agree to comply with and cause others to comply with the regulations of any registration and technical files which they may receive.

The Registration Contract signed between the Organizer and the Exhibitor will become effective upon acceptance of the admittance by said Organizer. Admittance applications submitted subject to conditions or reservations will not be processed.

**Article 3: ADMITTANCE CONTROL**

3.1/ - The application form for the Show is considered as the official Registration Contract, to the exclusion of any other, established by the Organizer and transmitted to the Exhibitor.

The application form, properly filled out and duly signed, accompanied by the payment as mentioned, is to be returned to the Organizer. Each application form is examined by the Organizer, which is solely empowered to rule on and confirm registration through an admittance notice. There exist no legal rights to admittance.

Requests regarding the spot to occupy, which will be taken into consideration as much as possible, will not be acknowledged as a condition to participation.

3.5/- Upon signature of said admittance application, the Exhibitors agree to comply with the Terms & Conditions hereby, the regulations published by the Municipality of Antibes and by the Vauban Port, in particular, concerning security matters.

3.7/ Save prior written authorization by the Organizer, an Exhibitor may not transfer, sublet or share, whether free of charge or against payment, any portion of its concession in whole or in part on the Show premises. However, several Exhibitors may be authorized to conduct a presentation together, under the condition that each of them forward a prior request for approval to the Organizer and make a co-participation request.

**Article 4: REGISTRATION & PARTICIPATION FEES**

The Registration Contract, under penalty of immediate refusal, is accompanied by a 30% deposit of the reservation amount (not including tax). Non payment of any one of the instalments at any one of the stipulated due dates entails loss of exhibiting rights. The down payment hence remains irrevocably in the possession of the Organizer, who can then make use of the stand at own discretion. Furthermore, the Organizer reserves the right to pursue collection of the balance of the price due, despite non participation, for whatever reason, of the registered Exhibitor.

Should an Exhibitor, for any reason whatsoever, not occupy its stand 24 hours before the official opening of the Show, it will be deemed a default. Without prejudice to any other measures taken, and at Exhibitor's own risk, the Organizer may make use of the defaulting Exhibitor's spot without said Exhibitor being able to claim any refund or compensation, even if the stand is allotted to another Exhibitor. In the case of non occupation of the stand for any reason whatsoever, any sums paid for stand rental, remain in the possession of the Organizer, even in the case of rental to another Exhibitor.

#### Article 5: PAYMENT CONDITIONS

5.2/ Payment conditions for the Show are as follows: 30% of the total amount including tax ('TTC') upon signature of the contract, by bank check to the order of the Organizer: Antibes Yacht Show, or by direct bank transfer to the account of Antibes Yacht Show, 9 Avenue St Roch 06600 Antibes, Domiciliation: Banque Populaire BPCA Nice Entreprises, Bank Code 15607 - Branch Code 00065- Account number 60621201219 Key bank identification number# 19 IBAN FR76 15607000656062120121919 Address Swift (BIC) CCBPFRPPNCE

**Any registration applications received without the down payment will not be processed.** The balance will be paid as follows: 70% of the total TTC amount, must be paid before March 1st 2012. Should the Organizer be in a position to refuse a registration, the reservation deposit will be refunded less the administration fee, which remains in its possession and amounts to €360.00 not including tax.

5.5/ If an exhibitor wishes to terminate his contract of registration, he must do so in writing by registered mail. The refund of any payments already received will be handled as follows:

If the request for cancellation is received not later than 75 days before the 1st day of the show, the exhibitor will receive a full refund (exemption of registration fees) If the cancellation request is received between 30 and 74 days before the 1st day of the show, the deposit will be retained by the organizer.

If the request is received within 30 days of the 1st day of the exhibition, the exhibitor forfeits the deposit paid and is liable for the full amount outstanding on his application form.

**6.3/ Spots will be allocated by the Show Committee. The Organizer sets down a plan of the Show and proceeds with distribution of said spots. It reserves the right to**

**change the layout of the space requested by Exhibitor.** It falls under Exhibitor responsibility, however, to ensure compliance and appropriateness of the granted spots with their Specifications, before outfitting same.

6.4/ The Organizer set down the plan for the event and allocate the spots. The Organizer reserves the right to change the surface area, layout and placement of said spaces as many times it deems useful, in the interest of the event.

#### Article 9: INSURANCE

9.1/ Each exhibitor is required to take out appropriate insurance in the context of this event. In no case can the organizers, acting in this capacity, assume any liability. Notwithstanding this, and where necessary, exhibitors are supplied with 2 forms permitting them to subscribe, directly with the insurers of the event, to a "Multi-risk Exhibitor" contract and/or a "Cancellation" contract. Conditions of such coverage are also provided.

9.2 /- Any eventual damage, theft or loss must be promptly declared to the Police Service, insurance company and to the Organizer. With a portion of the Show taking place on public maritime property, the Organizer will in no case whatsoever be held liable for any loss which may occur to Exhibitor assets during the course of the Show. Each Exhibitor must attend to its own surveillance of its assets.

9.3/ - The Organizer does not assume any obligation whatsoever of guardianship for items on display or for stand equipment, and will not be held liable for any damage or loss. The security measures taken by the Organizer do not restrict in any way the said condition and the Organizer will in no case whatsoever be held liable. The Exhibitor is fully and solely liable for any damage to equipment or to parties caused by

said Exhibitor, by persons under its responsibility or by any object or animal belonging to same or which it has in its custody, or by any element of its stand, decoration, hanging or other, whose assembly or disassembly and compliance with regulations is conducted under the Exhibitor's full responsibility.

#### Article 11: WASTE MANAGEMENT / CLEANING - GUARDIAN SERVICE

11.1/ The Organizer proceeds with cleaning of the Show site and alleys during assembly and disassembly. Exhibitors must bear charges for the complete cleaning of their stands, complying with the regulations in effect governing the recycling of certain waste.

11.2/ Overall surveillance of the site by night for assembly and disassembly for the duration of the Show is ensured by the Organizer. Control commences on the first day of assembly and ends the last day of disassembly. Exhibitors must ensure surveillance of their own belongings, particularly valuable items displayed on the stand. Should the need arise, they must order specific surveillance service for their stand if the items on display are of substantial value. Despite on site security service arrangements, the Organizer cannot be held liable for the disappearance of any items from the stands.

13.3/ The regulations hereby fall under French Law. Any disputes arising from the finalization, performance or interpretation of the regulations hereby and/or reservation of rental contract will fall under the sole jurisdiction of the Antibes Commercial Court, even in the case of summary court proceedings or expert appraisal. French will be the prevailing language of the Contract and solely the French version of any contract documents will be deemed authentic in the case of diverging interpretation of terms.
